Personal data that we process

Baiyiled Europe B.V. Processes your personal data because you make use of our services and/or you have provided us with your data. Below you will find an overview of the personal data that we process:

- First and last name - Date of birth - Address details – Phone number - E-mail address - Other personal data you provide, for example by creating a profile on this website, in correspondence and/or by phone - Information about your activities on our website - Information about your surfing behaviour across different websites (e.g. because this company is part of an ad network) - Bank account number

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. For which purpose and on what basis we process your personal data

Baiyiled Europe B.V. processes your personal data for the following purposes:

- Handling your payment - Sending our newsletter and / or advertising leaflet – To call and/or email you in case necessary to carry out our services – Inform you about changes to our services and products – To give you the possibility to create an account - To deliver goods and services to you

Automated decision-making

Baiyiled Europe B.V. does not take decisions based on automated processing on matters that can have (significant) consequences for people. This concerns decisions taken by computer programs or systems, without involving a person (for example, a Baiyiled Europe B.V. employee).

How long we store personal data

Baiyiled Europe B.V. does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. This depends on whether an account is created on our website. We will retain the personal data until it is indicated that the account is no longer required. If you do not have an account, your data will be deleted immediately.

Sharing personal data with third parties

Baiyiled Europe B.V. provides only to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

Baiyiled Europe B.V. uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Baiyiled Europe B.V. uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work well and to optimize it. In addition, we place cookies that keep track of your browsing habits so that we can offer customized content and advertisements. On your first visit to our website we have already informed you about these cookies and asked permission for their placement. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. You can do this yourself through the personal settings of your account. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you. If you wish to exercise your right of objection and / or right to data portability or if you have other questions / comments about data processing, please send a specified request to info@baiyiled.nl. To ensure that the request for access has been made by you, we ask you to send a copy of your identity document with the request. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number black. This is to protect your privacy. Baiyiled Europe B.V. will respond to your request as soon as possible, but in any case, within four weeks. Baiyiled Europe B.V. also wants to point out that you can file a complaint with the national supervisory authority, the Dutch Data Protection Authority. This can be done via the following link:
